have received and read the Parent Handbook and will comply with all provisions contained herein, and shall at this time enter into agreement with The Zone for the care of our child/children:

A rate of \_\_\_\_\_ per week will be charged to my account each Monday of each week that my child/children are enrolled at The Zone. I understand that this charge will not be reduced because of child's/children's absences. I understand that The Zone has the right to increase this fee. A new contract will be signed each time fees change.

I understand that my childcare fee must be paid by Wednesday of each week. I understand that The Zone will be closed for seven (7) holidays each year, and that I will be required to pay normal daily rates during holidays that The Zone is closed. For 2009-2010, these holidays are:

1. New Years Day (Friday, January 1st)
2. Labor Day (Monday, September 7th)
3. Thanksgiving Day (Thursday, November 26th)
4. Christmas Eve (Thursday, December 24th)
5. Christmas Day (Friday, December 25th)

The Zone summer camp will be closed on the following holidays:

1. Memorial Day (Monday, May 31st)
2. Independence Day (Monday, July 5th)

I understand that I will be required to pay a late pick-up fee of \$5.00 per minute if I pick up my child/children from The Zone after 6:30pm.

Damages: Children are taught to carefully handle materials to help avoid breakage & some breakage is expected due to normal wear and tear. Willful destruction will not be tolerated. In the event that your child willfully breaks or damages The Zone facility, vehicles belonging to The Zone, or any items on or in The Zone property, parent agrees to pay the cost of replacement or repairs for damages. This payment is expected within seven (7) days of notification.

Agreement: Both Parents and The Zone understand that this is a legally binding contract and agree to abide by the guidelines outlined herein. Parent also agrees to follow all policies in the parent handbook that has been provided. Parent or provider may terminate this contract at any time by providing written & paid two weeks notice. No other form of notice shall be accepted. If parent wishes to terminate this agreement without notice, he/she agrees to pay the 2 week fees at the time of termination. If parent breaches contract he/she will be liable for all collection and court costs involved. In the event that provider wishes to terminate the agreement without notice, provider agrees to refund any prorated fees already paid.

Immediate Termination: In the unlikely event that any of the following occur, The Zone reserves the right to give immediate termination without refunding fees: Willful destruction of property; if the child poses a threat to the safety and welfare of other children at The Zone; any physical or verbal abuse perpetrated by the parent upon The Zone employees or anyone in The Zone's care; unpaid balances; refusal to follow policies.
